Chief, Camoia, it was a pleasure to speak to you earlier today. Thank you for taking the time to discuss the issue of a potential sightline problem with my proposed stone fence. As I mentioned over the phone, my friends (including Martin Scheidl, whose email I am forwarding) were able to install a model of where the proposed stone fence's upper outer edge (closest to the road) would be in relation to the road surface around that corner. Martin also captured images and videos which he thought might be helpful in evaluating the issue of visibility. Please find those below.
Martin indicated to me that most of the photos and all of the videos were taken from the eye-level height of a driver in a low car (about 42" above the pavement).
He further indicated that the top edge of the plywood represents 30 inches above the ground (when it is graded to be approximately level with the top of the curb) and the outside top edge of the proposed solid stone fence.
He further commented, "You can see that the wall would not interfere with driver sightlines, even for someone low to the ground. It's the sightlines uphill that are much more blocked and dangerous for a driver in that intersection."
Martin is available to meet you there tomorrow afternoon to review the model in place between noon and 2pm or between 3pm and 4pm, if there are any convenient times for you within those available time slots of his. Please let me know what would be best for you and I will let him know.
Again, I appreciate your interest in understanding exactly how I propose the fence profile to exist at that corner and I am open to any safety-related suggestions for plan modifications if you feel there remains a material public safety issue. I would also just mention that it may be best to evaluate it

from the perspective of motorists pulling up beyond that existing stop sign white stripe, because if

Cherry Lane without doing so, and those cars do tend to approach that intersection a bit faster than those approaching from down Cherry Lane.
